#### **Executive Summary**

#### Output, Prices and Employment

Real GDP at market prices grew by 2.8 percent during the first quarter of 2023, compared to a growth of 2.5 percent during the same quarter of 2022. The general price level, measured by the percentage change in the Consumer Price Index (CPI) increased during the first half of 2023 by 3.0 percent, compared to an increase of 3.3 percent during the same period of 2022. The unemployment rate during the first quarter of 2023 reached 21.9 percent, compared to 22.8 percent during the same quarter of 2022.

- **Public Finance:** The general budget, including foreign grants, recorded a fiscal deficit in the amount of JD 262.1 million (2.3 percent of GDP) during the first four months of 2023, comparing to a fiscal deficit of JD 323.0 million (3.0 percent of GDP) during the same period of 2022. Government domestic debt (budgetary and guaranteed) increased by JD 177.9 million at the end of April 2023, compared to its level at the end of 2022, to reach JD 21,757.1 million (63.2 percent of GDP). Moreover, outstanding external debt (budget and guaranteed) went up by JD 1,046.8 million, to reach JD 17,957.8 million (52.2 percent of GDP). Accordingly, outstanding government debt (domestic and external) rose up to reach JD 39,714.9 million at the end of April 2023 (115.4 percent of GDP), compared to JD 38,490.2 million (114.2 percent of GDP) at the end of 2022. When excluding the debt holding by the Social Security Investment Fund, the government domestic debt (budget and guaranteed) stand at JD 13,967.0 million (40.6 percent of GDP). - External Sector: Total merchandize exports (domestic exports plus re-exports) increased by 6.3 percent during the first quarter of 2023 to reach JD 2,118.5 million. Meanwhile, merchandize imports increased by 5.6 percent to reach JD 4,513.8 million. As a result, the trade balance deficit increased by 4.9 percent, compared to the same quarter of 2022, to reach JD 2,395.3 million. The preliminary data during the first half of 2023 showed an increase in travel receipts by 59.4 percent, to reach JD 2,450.3 million, and an increase in travel payments by 46.5 percent, to reach JD 642.0 million, compared to the same period of 2022. Moreover, total workers' remittances receipts decreased by 1.5 percent during the first five months of 2023, to reach JD 992.4 million, compared to the same period of 2022. The preliminary data for the balance of the same period of 2022. The preliminary data for the balance of payments during the first quarter of 2023 displayed a deficit in the current account amounted to JD 714.4 million (8.8 percent of GDP) compared to a deficit of JD 911.9 million (11.8 percent of GDP) during the same quarter of 2022. Meanwhile, the current account deficit excluding grants decreased to reach 10.2 percent of GDP, compared with 12.9 percent of GDP during the same quarter of 2022. Moreover, foreign direct investment recorded an inflow of JD 199.9 million during the first quarter of 2023, compared to an inflow of JD 288.5 million during the same quarter of 2022. Furthermore, the international investment position (IIP) registered a net obligation to abroad amounted to JD 37,193.2 million at the end of the first quarter of 2023, compared to a net obligation to abroad by JD 36,571.9 million at the end of 2022.





#### Components of Domestic Liquidity

Total deposits, according to liquidity definition, amounted to JD 35.8 billion at the end of June 2023, compared to JD 34.5 billion during the same period in 2022, and JD 35.6 billion at the end of 2022.



The CBJ decided during 2022 to raise interest rates seven times by 400 basis points on all monetary policy instruments and 425 basis points on O/N window rate. During this year the CBJ raised the

interest rates on 30/7/2023 by 25 basis points on all monetary policy instruments, and this is for the third time during 2023, to become as follow:

- The CBJ main interest rate: 7.50 percent.
- Re-discount Rate: 8.50 percent.
- Interest Rate on Overnight Repurchase Agreements: 8.25 percent.
- Overnight Deposit Window Rate: 7.25 percent.
- Weekly/ Monthly Repurchase Agreements: 7.50 percent.
- The interest rate on weekly certificates of deposit: 7.50 percent.

This decision comes in line with the continuation of the inflationary pressures in the regional and international economic environment, compared to the rates targeted by Central Banks, which contributed to a rise in the recorded inflation rates in the Kingdom at 2022 and their expectations within the short-term.



Within the CBJ's keenness for the importance of achieving a balance between its objective to maintain monetary stability, and continuing to stimulate economic growth and mitigating the impact of raising interest rates on economic sectors, the CBJ decided to extend the CBJ's program to refinance the vital economic sectors, with a value of JD 1.4 billion, covering ten sectors, and to keep the interest rate for this program unchanged at 1.0% for projects in Amman, and 0.5% for projects in the other governorates, in order to provide financing for productive activities with preferential terms.

#### Interest Rates in the Banking Sector

#### Interest Rates on Deposits

• Time Deposits: The weighted average interest rate on time deposits increased by 6 basis points at the end of June 2023, compared to its level registered at the previous month to stand at 5.54%. This rate is higher by 93 basis points than its level registered at the end of 2022.



- Saving Deposits: The weighted average interest rate on saving deposits stood at 0.40% at the end of June 2023, maintaining the same level registered at the end of the previous month. This rate is lower by one basis point than its level registered at the end of 2022.
- Demand Deposits: The weighted average interest rate on demand deposits decreased by 2 basis points at the end of June 2023, compared to its level registered at the previous month to stand at 0.53%. This level is higher by 16 basis points than its level registered at the end of 2022.



#### Interest Rates on Credit Facilities

- Overdraft Accounts: The weighted average interest rate on overdraft accounts decreased by 24 basis points at the end of June 2023, compared to its level registered at the previous month to stand at 9.05%. This level is higher by 75 basis points than its level registered at the end of 2022.
- Discounted Bills and Bonds: The weighted average interest rate on "discounted bills and bonds" increased by 79 points basis at the end of June 2023,compared to its level registered at the previous month to stand at 9.05%. This level is higher by 69 basis points, than its level registered at the end of 2022.
- Loans and Advances: The weighted average interest rate on "loans and advances" increased by 8 basis points at the end of June 2023, compared to

its level registered at the previous month to stand at 9.16%. This level is higher by 82 basis points than its level registered at the end of 2022.

• The prime lending rate stood at 11.40% at the end of June 2023, increasing by 5 basis points compared to its level registered at the previous month. This level is higher by 60 basis points that its level registered at the end of 2022.

#### Credit Facilities Extended by Licensed Banks

- Total credit facilities extended by licensed banks increased by JD 901.8 million, or 2.8 percent, at the end of June 2023, compared to its level registered at the end of 2022, against an increase by JD 1,799.5 million, or 6.0 percent during the same period in 2022.
- In terms of borrower sectors, the credit facilities at the end of June 2023 had shown an increase in credit extended to the private sector (resident) by JD 552.0 million, or 1.9 percent, the central government by JD 222.9 million, or 10.9 percent, the public institution by JD 102.1 million, or 11.1 percent, and the credit facilities extended to the private sector (non-resident) by JD 39.6 million, or 6.0 percent. In contrast, the non-banking financial institutions decreased by JD 14.8 million, or 15.6 percent, compared to their levels at the end of 2022.

#### **Deposits at Licensed Banks**

Total deposits at licensed banks stood at JD 42.5 billion at the end of June 2023, compared to JD 40.9 billion at the end of June 2022, and JD 42.1 billion at the end of 2022.

The currency composition of deposits at the end of June 2023 revealed that the JD deposits amounted to JD 33.2 billion, and the deposits in foreign currencies amounted to JD 9.3 billion, compared to JD 31.8 billion of JD deposits, and JD 9.1 billion of deposits in foreign currencies at the end of June 2022, and JD 32.8 billion of JD deposits, and JD 9.3 billion of deposits in foreign currency at the end of 2022.

#### Amman Stock Exchange (ASE)

The ASE main indicators showed a mixed performance during June 2023, compared to their levels in 2022. This can be demonstrated as follows:

#### Trading Volume

Trading volume at ASE totaled JD 102.0 million in June 2023, decreasing by JD 13.7 million, or 11.9 percent, compared to its level registered at the end of the previous month, against an increase by JD 49.5 million, or 27.7 percent during the same month in 2022. As for the first half of 2023, the trading volume totaled JD 863.3 million.

#### Traded Shares

The number of traded shares in June 2023 totaled 85.2 million shares, decreasing by 18.5 million shares, or 17.8 percent, compared to its level registered at the end of the previous month, against an increase by 56.5 million shares, or 65.0 percent during the same month in 2022. As for the first half of 2023, the number of traded shares amounted to 593.5 million shares.

an increase by 3.5 basis points, or 0.1 percent during the same period in 2022. Furthermore, the SPI decreased by 36.1 points, or 1.4 percent compared to its level registered at the end of 2022, against an increase by 357.4 basis points, or 16.9 percent during the same period in 2022. The aforementioned decrease was an outcome of the decrease in the SPI of the industrial sector by 74.7 points, or 1.4 percent, and the financial sector by 65.9 basis points, or 2.4 percent, while the decrease in the SPI of the services sector increased by 16.3 basis points, or 0.9 percent compared to their levels at the end of 2022.

#### Market Capitalization

The ASE's market capitalization totaled JD 17.4 billion at the end of June 2023, decreasing by JD 243.3 million, or 1.4 percent, compared to its level registered at the previous month, against a decrease by JD 218.1 million, or 1.2

Non-Jordanian net investment ASE at recorded outflow an amounted of JD 2.7 million in June 2023, compared to an outflow amounted by JD 39.5 million during the same months of 2022. The value of shares buying by non-Jordanian in June 2023 amounted to JD 6.0 million, while their selling

#### Second: Output, Prices and Employment

#### **Summary**

- Gross Domestic Product (GDP), at constant market prices, grew by 2.8 percent during the first quarter of 2023, compared to a growth of 2.5 percent during the same quarter of 2022. At current market prices, GDP grew by 5.1 percent during the first quarter of 2023, compared to a growth of 4.6 percent in the same quarter of 2022.
- The general price level, measured by the percentage change in the Consumer Price Index (CPI) increased during the first half of 2023 by 3.0 percent, compared to an increase of 3.3 percent during the same period of 2022.
- The unemployment rate during the first quarter of 2023 reached 21.9 percent (19.6 percent for males and 30.7 percent for females), compared to 22.8 percent (20.5 percent for males and 31.5 percent for females) during the same quarter of 2022. The highest unemployment rate was among youth, which reached 57.2 percent for the (15-19) years old category and 44.2 percent for the category (20-24) years old.

#### **Output, Prices and Employment**

#### **July 2023**

#### **Developments of GDP**

Gross Domestic Product (GDP), at constant market prices, grew by 2.8 percent during the first quarter of 2023, compared to a growth of 2.5 percent during the same quarter of 2022. When excluding "net taxes on products" (which grew by 1.4 percent during the first quarter of 2023 compared to a growth of 2.3 percent during the same quarter of 2022), GDP at constant basic prices, grew by 3.0 percent during the first quarter of 2023, compared to a growth of 2.5 percent during the same quarter of 2022).

At current market prices, GDP grew by 5.1 percent during the first quarter of 2023, compared to a growth of 4.6 percent during the same quarter of 2022. This was in light of the increase of the general price level, measured by the GDP deflator, by 2.2 percent during the first quarter of 2023 compared to a growth of 2.0 percent during the same quarter of 2022.

The economic growth recorded during the first quarter of 2023 was driven by the improvement in some indicators of extrnal sector, such as; tourism income, domestic exports, and some indictors of "mining and quarrying" sector such as the production of phosphate and potash.

As for the economic sectors contribution to growth rate during the first quarter of 2023, all sectors contributed positively to the growth rate. Most notably; manufacturing contributed by (0.6 percentage point), "transport, storage and communications" (0.4)percentage point), agriculture (0.4)percentage point), "finance and insurance services" (0.3)percentage point), and "wholesale and retail trade" (0.2 percentage point). These sectors accounted for 67.9 percent of the real growth recorded during the first quarter of 2023.



#### **Monthly Report**

#### **Prices**

The general price level, measured by the percentage change in the Consumer Price Index (CPI), increased during the first half of 2023 by 3.0 percent, compared to an increase of 3.3 percent during the same period of 2022. This was an outcome of the following:

- An increase in the prices of some items and groups, most notably:
  - "fuel and lighting" prices increased by 15.0 percent, compared to an increase by 17.5 percent, in addition to the transportation group, whose the prices increased by 2.6 percent, compared to an increase by 5.5 percent during the first half of 2022. and this comes in light of the rise in oil prices in global markets.

#### **Output, Prices and Employment**

#### July 2023

- The price of the items "dairy products and eggs" and "cereals and products" increased by 8.4 percent and 4.5 percent compared to an increase by 2.0 percent and 3.0 percent, respectively, during the first half of 2022, affected partly by the demand and supply factors in domestic market.
- In addition to rising rents item by 4.8 percent compared to an increase by 0.6 percent during the first half of 2022.
- The health group also increased by 5.6 percent compared to an increase by 0.5 percent during the first half of 2022, this increase is partially due to the increase in prices of medical and hospital services.

The above groups and items collectively contributed to raising the inflation rate during the first half of 2023 by 2.7 percentage points, compared to 2.0 percentage points during the same period of 2022.

• On the other hand, the price of some items decline, notably; "vegetables and legumes dry and canned" (14.8 percent) and clothes (1.5 percent), during the first half of 2023.

In May 2023, the CPI witnessed an increase compared to the previous month (May 2023) by 0.2 percent. This was an outcome of the increase in the prices of some items and groups, mainly, rent (2.2 percent), "meat and poultry" (4.2 percent), on the one hand, and the decrease of the prices of a number of other items, most notably; transportation (1.3




percent), and "vegetables and legumes dry and canned" (3.2 percent), on the other hand.

#### **Labor Market**

The unemployment rate reached 21.9 percent (19.6 percent for males, and 30.7 percent for females) during the first quarter of 2023, compared to 22.8 percent (20.5 percent for males and 31.5 percent for females), during the same quarter of 2022.



- The unemployment rate among youth, during the first quarter of 2023, remains high reaching 57.2 percent for the category (15-19) years old, and 44.2 percent for the category (20-24) years old.
- The unemployment rate among academic degree holders (Bachelor and higher) reached 25.8 percent during the first quarter of 2023, and the unemployment rate among (less than secondary) reached 20.5 percent.
- The refined economic participation rate (the ratio of the labor force to the population of 15 years and over), was 33.3 percent (53.3 percent for males, and 13.7 percent for females), compared to 33.2 percent (53.2 percent for males and 13.7 percent for females) during the first quarter of 2022.
- The employment rate among population (15 years and older) reached 26.0 percent during the first quarter of 2023.

#### **Third: Public Finance**

#### **Summary:**

- The general budget, including foreign grants, recorded a fiscal deficit in the amount of JD 262.1 million (2.3 percent of GDP) during the first four months of 2023, comparing to a fiscal deficit of JD 323.0 million (3.0 percent of GDP) during the same period of 2022. When excluding foreign grants (JD 15.9 million), the general budget deficit increases to JD 278.0 million (2.4 percent of GDP), compared to a deficit of JD 363.7 million (3.3 percent of GDP) in the same period of 2022.
- Government domestic debt (budgetary and guaranteed) increased by JD 177.9 million at the end of April 2023, compared to its level at the end of 2022, to reach JD 21,757.1 million (63.2 percent of GDP). When excluding the domestic debt holding by the Social Security Investment Fund, the government domestic debt (budgetary and guaranteed) stand at JD 13,967.0 million (40.6 percent of GDP).
- Outstanding external debt (budget and guaranteed) went up by JD 1,046.8 million at the end of April 2023, compared to its level at the end of 2022, to reach JD 17,957.8 million (52.2 percent of GDP). When excluding the external debt holding by the Social Security Investment Fund, the outstanding external debt (budget and guaranteed) stand at JD 17,495.2 million (50.8 percent of GDP).
- As a result, outstanding government debt (domestic and external) rose by JD 1,224.7 million at the end of April 2023, to reach JD 39,714.9 million (115.4 percent of GDP), compared to JD 38,490.2 million (114.2 percent of GDP) at the end of 2022. When excluding the government debt holding by the Social Security Investment Fund, the outstanding government debt (domestic and external) stand at JD 31,462.2 million (91.4 percent of GDP), compared to JD 30,667.6 million (91.0 percent of GDP) at the end of 2022.

# □ The performance of the general budget during the first four months of 2023 compared with the same period of 2022:

#### Public Revenues

Public revenues (domestic revenues *plus* foreign grants) increased by JD 126.3 million, or 13.7 percent, in April 2023 compared to the same month in 2022, to stand at JD 1,046.5 million. As for the first four months of 2023, public revenues went up by JD 273.4 million, or 9.8 percent, compared to same period of 2022, to stand at JD 3,052.1 million. This came as an outcome of the increase in domestic revenues by JD 298.2 million, and decrease in foreign grants by JD 24.8 million.



#### Domestic Revenues

Domestic revenues witnessed an increase of JD 298.2 million, or 10.9 percent, in the first four months of 2023, compared to the same period of 2022, to reach JD 3,036.2 million. This increase was a result of the rise in the proceeds of "tax revenues", "other revenues" by JD 179.4 million, JD 118.9 million, respectively.

#### • Tax Revenues

Tax revenues increased by JD 179.4 million, or 8.2 percent, during the first four months of 2023, compared to the same period of 2022, to reach JD 2,354.6 million (77.6 percent of domestic revenues). Following are



the main developments in tax revenue items:

- A decrease in the proceeds of general sales tax on goods and services by JD 47.5 million, or 3.7 percent, to reach JD 1,241.1 million, accounting for 52.7 percent of total tax revenues. This result was driven by the decrease in the proceeds of sales tax on commercial sector by JD 79.9 million, and increase in the proceeds of sales tax on domestic goods by JD 22.2 million, and on services by JD 7.7 million, and on imported goods by JD 2.5 million.



- An increase in the proceeds of **income and profit taxes** by JD 217.3 million, or 27.5 percent, to reach JD 1,006.1 million, accounting for 42.7 percent of total tax revenues. This increase came mainly as a result of the increase in the proceeds of "income taxes from companies and projects" by JD 192.0 million, or 29.8 percent, to account for 83.2 percent of total proceeds of income and profits taxes, amounting to JD 837.0 million, and increase the proceeds of "income taxes from individuals" by JD 5.3 million, or 4.3 percent, to reach JD 129.1 million, and increase the proceeds of national contribution account item by JD 20.0 million, to reach JD 40.0 million.

#### - An increase in the proceeds of taxes on financial transactions

(real-estates tax) by JD 6.0 million, or 24.1 percent, to reach JD 30.9 million.

- An increase in the proceeds of **taxes on international trade** 



and transactions (including customs duties and fees) by JD 3.6 million, or 4.9 percent, to reach JD 76.5 million.

#### Non-Tax Revenues

- "Other revenues" increased by JD 118.9 million, or 21.2 percent, during the first four months of 2023, to reach JD 680.4 million. This increase was chiefly due to the following:
  - An increase in miscellaneous revenues by JD 76.7 million to stand at JD 283.7 million.
  - An increase in the property income by JD 39.4 million to stand at JD 122.3 million (of which financial surplus of independent government units amounted to JD 104.2 million against JD 72.9 million during the same period of 2022).
  - An increase in revenues from selling goods and services by JD 2.7 million to reach JD 274.4 million.
- Pension contributions maintaining the same level achieved during the first four months of 2023, compared to the same period of 2022, standing at JD 1.3 million.


Foreign grants decreased by JD 24.8 million, or 60.9 percent, during the first four months of 2023, standing at JD 15.9 million, compared to JD 40.7 million during the same period of 2022.

#### Public Expenditures

Public expenditures increased by JD 28.3 million, or 3.2 percent, in April 2023 compared to the same month in 2022, to stand at JD 925.7 million. As for the first four months of 2023, public expenditures increased by JD



212.5 million, or 6.9 percent, compared to the same period of 2022, to stand at JD 3,314.2 million. This increase was a result of the rise in current expenditures by 6.2 percent, and capital expenditures by 15.7 percent.


#### Current Expenditures

Current expenditures went up by JD 177.6 million, or 6.2 percent, during the first four months of 2023, to reach JD 3,057.0 million (92.2 percent of public expenditures). Because of the growth rate of domestic revenues is higher than that of current expenditure, the coverage ratio (measured by the ratio of domestic revenues to current expenditures) increased by 4.2 percentage point, to reach 99.3 percent compared to 95.1 percent during the same period of 2022. The increase in current expenditures is due to the evolution of its components, as follow:

- An increase in **interest payments** (commitment basis) by JD 91.7 million, to stand at JD 590.1 million.
- An increase in military expenditures by JD 30.7 million, to total JD 958.5 million.
- An increase in the compensation of civil sector's employees (wages, salaries and social security contributions) by JD 24.5 million, to reach JD 626.6 million.
- An increase in **pensions and compensation** by JD 13.9 million, to stand at JD 556.9 million.
- An increase in the purchases of goods and services by JD 9.0 million, to reach JD 108.0 million.
- An increase in subsidies

   stand at JD 62.5 million.


Capital expenditures increased by JD 34.9 million, or 15.7 percent, during the first four months of 2023 compared to the same period of 2022, to reach JD 257.2 million.

#### General Budget Deficit/ Surplus

The overall fiscal deficit, including foreign grants, decreased by JD 60.9 million, during the first four months of 2023, to reach JD 262.1 million (2.3 percent of GDP), compared to a fiscal




deficit of JD 323.0 million (3.0 percent of GDP) in the same period of 2022. When foreign grants are excluded, the general budget deficit increases to reach JD 278.0 million (2.4 percent of GDP), compared to a fiscal deficit of JD 363.7 million (3.3 percent of GDP) in the same period of 2022.


The primary surplus, excluding foreign grants, (domestic revenues *minus* total public expenditures excluding interest payments on public debt) reached JD 312.1 million (2.7 percent of GDP) in the first four months of 2023, against a primary surplus of JD 134.7 million (1.1 percent of GDP) in the same period of 2022. When foreign grants are including, the primary surplus of the general budget reached JD 328.0 million (2.9 percent of GDP), compared to a primary surplus of JD 175.4 million (1.5 percent of GDP) in the same period of 2022.

### Outstanding Government Debt

Government domestic debt (budgetary and guaranteed) increased by JD 177.9 million, at the end of April 2023 compared to its level at the end of 2022, to stand at JD 21,757.1 million (63.2 percent of GDP). This increase was an outcome of the rise in the domestic debt of the budget by JD 26.3 million, and the increase in the domestic debt of guaranteed by JD 151.7 million, compared to their levels at the end of 2022, standing at JD 18,974.0 million and JD 2,783.1 million, respectively.





When excluding the domestic debt holding by the Social Security Investment Fund (SSIF), the government domestic debt (budgetary and guaranteed) decreased by JD 211.7 million, at the end of April 2023 compared to its level at the end of 2022, to stand at JD 13,967.0 million (40.6 percent of GDP).

- Outstanding external debt (budget and guaranteed) went up by JD 1,046.8 million at the end of April 2023, compared to its level at the end of 2022, to reach JD 17,957.8 million (52.2 percent of GDP). It is worth mentioning that the external debt denominated in the U.S. Dollar accounted for 70.6 percent of the total external debt, and the debt in Euro accounted for 10.9 percent. However, the SDR accounted for 10.3 percent, Kuwaiti Dinar (3.2 percent), and Japanese Yen (3.1 percent).
- When excluding the external debt holding by the Social Security Investment Fund, the outstanding external debt (budget and guaranteed) increased by JD 1,006.3 million, at the end of April 2023 compared to its level at the end of 2022, to stand at JD 17,495.2 million (50.8 percent of GDP).
- In light of the above-mentioned developments, outstanding government debt (domestic and external) increased by JD 1,224.7 million at the end of April 2023 to reach JD 39,714.9 million (115.4 percent of GDP), compared to JD 38,490.2 million (114.2 percent of GDP) at the end of 2022. When excluding the debt holding by the Social Security Investment Fund, the outstanding government debt (budget and guaranteed) stand at JD 31,462.2 million (91.4 percent of GDP), compared to JD 30,667.6 million (91.0 percent of GDP) at the end of 2022.
- External debt service (budget and guaranteed) decreased by JD 317.6 million during the first four months of 2023 compared to the same period of 2022, to reach JD 378.7 million (including principal payments of JD 137.0 million and interest of JD 241.7 million).

### **Fourth: External Sector**

#### **Summary**

- Total merchandize exports (domestic exports *plus* re-exports) decreased by 15.6 percent in March 2023, compared to the same month of 2022, to reach JD 655.2 million. As for the first quarter of 2023, total export increased by 6.3 percent, compared to the same quarter of 2022, to reach JD 2,118.5 million.
- Merchandize imports decreased by 0.8 percent in March 2023, compared to the same month of 2022, to reach JD 1,503.9 million. As for the first quarter of 2023, import increased by 5.6 percent, compared to the same quarter of 2022, to reach JD 4,513.8 million.
- Consequently, the trade balance deficit (total exports minus imports) increased by 14.7 percent in March 2023, compared to the same month of 2022; standing at JD 848.7 million. As for the first quarter of 2023, trade balance deficit increased by 4.9 percent, compared to the same quarter of 2022, to reach JD 2,395.3 million.
- Travel receipts increased by 59.4 percent during the first half of 2023, to register JD 2,450.3 million, compared to the same period of 2022. While, travel payments increased by 46.5 percent, to register JD 642.0 million, compared to the same period of 2022.
- **Total workers' remittances receipts** decreased by 1.5 percent during the first five months of 2023, compared to the same period of 2022, to reach JD 992.4 million.
- The current account of the balance of payments (including grants) registered a deficit amounted to JD 714.4 million (8.8 percent of GDP) during the first quarter of 2023, compared to a deficit of JD 911.9 million (11.8 percent of GDP) during the same quarter of 2022. Meanwhile, the current account deficit excluding grants decreased to reach 10.2 percent of GDP, compared with 12.9 percent of GDP during the same quarter of 2022.
- Foreign direct investment recorded an inflow of JD 199.9 million during the first quarter of 2023, compared to an inflow of JD 288.5 million during the same quarter of 2022.

### **July 2023**

International investment position (IIP) displayed a net obligation to abroad of JD 37,193.2 million, at the end of the first quarter of 2023, compared to net obligation amounted to JD 36,571.9 million at the end of 2022.

### **External Trade**

As a result of the increase in domestic exports by JD 159.6 million and the increase in imports by JD 237.4 million during the first quarter of 2023, the volume of external trade (domestic exports plus imports) increased by JD 397.0 million to stand at JD 6,488.6 million, compared to the same quarter of 2022.



## Merchandize Exports:

Total merchandize exports increased by 6.3 percent during the first quarter of 2023, to reach JD 2,118.5 million. This increase was an outcome of the increase in domestic exports by JD 159.6 million, or 8.8 percent to



reach JD 1,974.8 million, and the decrease in re-exports by JD 33.9 million, or 19.1 percent to reach JD 143.7 million.

- The developments of domestic exports during the first quarter of 2023, compared with the same quarter of 2022 reveals the following:
  - Exports of **phosphoric acid** increased by JD 132.7 million, or 94.3 percent to reach JD 273.4 million. It is worth noting that markets of India, Bangladesh and Saudi Arabia accounted for 99.2 percent of these exports.
  - Exports of "Medical & Pharmaceutical Products" increased by JD 18.1 million, or 21.2 percent, to stand at JD 103.6 million. Saudi Arabia, the USA, and Algeria were the main destination markets for these exports, accounting for 46.7 percent.
  - Exports of "**Polishing & Cleaning Preparations & Perfume Materials**" increased by JD 15.8 million, or 41.3 percent, to reach JD 54.1 million. Iraq and Saudi Arabia were the main destination markets; accounting for 64.7 percent of these exports.

- Exports of "Paper and Major Domestic Exports by Commodity, JD Million Cardboard" increased by JD 9.1 million, or 28.2 percent, to stand at JD 41.1 million. The markets of Saudi Arabia, the Iraq and UAE accounted for 79.0 percent of these exports
- Exports of Clothes decreased by JD 7.7 million, or 2.5 percent, JD to reach 298.2 million. It is worth noting that the USA market accounted for 82.2 percent of these exports.
- Exports of **phosphates** decreased by JD 8.3 million, or 5.5 percent, to reach JD 141.7 million. The markets of India, Indonesia, Brazil and Taiwan accounted for 93.2 percent of these exports.




Pharmaceutical Products", Fertilizer, "Polishing & Cleaning Preparations & Perfume Material" and "Paper and Cardboard", topped the list of domestic exports during the first quarter of 2023; accounting for 60.4 percent, compared with 63.6 percent during the same quarter of 2022. Meanwhile, the geographical distribution of domestic exports indicates that India, the USA, Saudi Arabia, Iraq, China, Palestine and the UAE were the main destination markets during the first quarter of 2023; accounting for 65.9 percent, compared with 62.8 percent during the same quarter of 2022.

#### **July 2023**

### Merchandize Imports:

Merchandize imports increased by 5.6 percent to reach JD 4,513.8 million during the first quarter of 2023, compared to an increase by 31.0 percent during the same quarter of 2022.



- The developments of imports during the first quarter of 2023, compared with the same quarter of 2022, reveals the following:
- "Transport Equipment & Spare Parts" imports increased by JD 66.4 million, or 22.8 percent, to reach JD 358.1 million. China, the USA and South Korea were the main origin markets, accounting for 58.9 percent of these imports
- **Crude Oil** imports increased by JD 36.3 million, or 28.8 percent, to reach JD 162.5 million. Saudi Arabia and Iraq were the main origin markets, accounting for 100.0 percent of these imports.
- "Electrical Machinery, Apparatus and Appliances" imports increased by JD 28.9 million or 26.6 percent, to reach JD 137.4 million. China, Thailand and Turkey were the main markets, accounting for 51.6 percent of these imports.

- "Medical and Pharmaceutical Products" imports increased by JD 28.8 million, or 23.5 percent, to reach JD 151.6 million. The USA, Germany and Switzerland, were the main markets, accounting for 33.2 percent of these imports.
- Petroleum **Products** imports increased by JD 27.2 million, or 8.5 percent, to stand at JD 345.4 million. Saudi Arabia, India and the UAE were the main markets, for 97.9 accounting percent of these imports.
- Fruits & Vegetable & Nuts imports increased by JD 18.5 million or 15.7 percent to reach JD 136.3 million. The USA, Egypt and Belgium were the main origin markets accounting for 34.4 percent of these imports.


Major Imports by Commodity, JD Million

Consequently, the commodity composition of imports indicates that "Transport Equipment & Spare Parts", Petroleum Products, "Textile Yarn, Fabrics and Related Products", Crude oil. "Medical & Pharmaceutical Products", "Iron & Steel", "Electrical Machinery Apparatus and Appliances"



and "Fruits & Vegetable & Nuts", topped the list of imports during the first quarter of 2023, accounting for 36.0 percent, compared with 33.9 percent during the same quarter of 2022. Meanwhile, the geographical distribution of imports indicates that China, Saudi Arabia, the USA, India, the UAE, Turkey and Germany were the main source markets during the first quarter of 2023; accounting for 56.6 percent of imports, compared to 53.7 percent during the same quarter of 2022.

Re-Exports

The value of re-exported goods in March 2023 decreased by JD 9.0 million, or 14.8 percent, compared to the same month of 2022, to stand at JD 51.9 million. As for the first quarter of 2023, re-export decreased by 19.1 present, compared to the same quarter of 2022, to reach JD 143.7 million.

## Trade Balance

The trade balance deficit increased by JD 108.7 million, or 14.7 percent in March 2023, compared to the same month of 2022, to reach JD 848.7 million. As for the first quarter of 2023, trade balance deficit increased by 4.9 present, compared to the same quarter of 2022, to reach JD 2,395.3 million.

### **Total Workers' Remittances Receipts**

Total workers' remittances receipts decreased during the first five months of 2023 by JD 15.6 million, or 1.5 percent, to stand at JD 992.4 million, compared to the same period of 2022.

### **Travel**

### Receipts

Travel receipts increased by 59.4 percent during the first half of 2023, to register JD 2,450.3 million, compared to the same period of 2022.

### Payments

Travel payments increased by 46.5 percent during the first half of 2023, to register JD 642.0 million, compared to the same period of 2022.

#### **Balance of Payments**


The preliminary data for the balance of payments during the first quarter of 2023 reveals the following:

The current account recorded a deficit of JD 714.4 million (8.8 percent of GDP), compared to a deficit of JD 911.9 million (11.8 percent of GDP) during the same quarter of 2022. Meanwhile, the current account deficit (excluding grants) decreased to reach JD 825.8 million (10.2 percent of GDP), compared to a deficit of JD 1,001.4 million (12.9 percent of GDP) during the same quarter of 2022. This was an outcome of the following developments:

An increase in the goods account deficit by JD 84.2 million, or 4.6 percent, to reach JD 1,897.4 million, compared to a deficit of JD 1,813.2 million.



- An increase in the services account surplus, increased by JD 391.9 million, to reach JD 566.1 million, compared to a surplus of JD 174.2 million.
- The primary income account recorded a deficit of JD 109.7 million, compared to a deficit of JD 61.6 million. This was mainly due to the increase in the deficit of investment income (net) to reach JD 157.7 million, compared to deficit of JD 110.1 million, and the decrease of "compensation of employees (net)" surplus by JD 0.5 million to reach JD 48.0 million.
- The secondary income recorded a net surplus of JD 726.6 million, compared to a net surplus of JD 788.7 million. This was an outcome of a decrease in net surplus of other sectors transfers by JD 84.0 million to reach JD 615.2 million, and the increase in net surplus of the public sector (foreign grants) by JD 21.9 million to reach JD 111.4 million.

- As for the capital and financial transactions during the first quarter of 2023, the capital account registered a net inflow of JD 7.5 million, compared to a net inflow of JD 9.5 million during the same quarter of 2022. Meanwhile, the financial account registered a net inflow of JD 977.9 million during the first quarter of 2023, compared to a net inflow of JD 788.1 million during the same quarter of 2022, this could be attributed to the following:
  - Foreign direct investment recorded an inflow of JD 199.9 million compared to an inflow of JD 288.5 million.
  - Portfolio investment recorded a net outflow of JD 58.7 million compared to a net outflow of JD 83.0 million.
  - Other investment registered a net inflow of JD 326.3 million, compared to a net inflow of JD 435.3 million.
  - CBJ's Reserve assets registered a decrease by JD 535.1 million, compared to a decrease by JD 151.4 million.

## **International Investment Position (IIP)**

The IIP, which represents the Kingdom's net position (stock) of external financial assets and liabilities, displayed an obligation to abroad of JD 37,193.2 million at the end of the first quarter of 2023, compared to a net obligation by JD 36,571.9 million at the end of 2022. This was due to the following developments:

A decrease in the position of external assets (the stock of claims, obligations and financial assets) for all residing economic sectors in the Kingdom by JD 250.8 million at the end of the first quarter of 2023 to reach JD 20,700.8 million, compared to its level at the end of 2022. This was mainly due to the decrease of both CBJ's reserve assets by JD 308.7 million, currency and deposits of banking sector abroad by JD 30.7 million, and the increase of both trade credit of other sectors to abroad by JD 68.5 million, and the licensed banks loans to abroad by JD 12.5 million.

- An increase in the position of external liabilities (the stock of claims, obligations and financial liabilities) on all residing economic sectors in the Kingdom by JD 370.5 million at the end of the first quarter of 2023, to reach JD 57,894.0 million, compared to its level at the end of 2022. This was due to the following developments:
  - An increase in the stock of direct investment in the kingdom by JD 293.5 million, to stand at JD 27,543.2 million.
  - An increase in the deposits of non-residents at the banking sector by JD 278.8 million, to stand at JD 10,671.2 million (increase by JD 289.6 million for the licensed banks, and a decrease by JD 10.8 million for the CBJ).
  - An increase in outstanding balance of government loans (long-term) by JD 133.4 million, to stand at JD 6,998.1 million.
  - An increase in outstanding balance of the international monetary fund credit facilities by JD 14.3 million, to reach JD 1,713.3 million.
  - A decrease in the stock of portfolio investment in the kingdom by JD 305.7 million, to stand at JD 6,606.9 million.
  - A decrease in outstanding balance of licensed banks loans (short-term) by JD 60.2 million, to stand at JD 726.1 million.
  - A decrease of trade credits to non-residents in the kingdom by JD 36.2 million, to stand at JD 935.2 million.
  - A decrease in outstanding balance of other sectors loans (longterm) by JD 14.5 million, to stand at JD 1,990.7 million.
